This plan was developed during the COVID-19 pandemic which caused school closures and significantly disrupted our normal cadence of families, students, and staff engagement. However, resuming in-person instruction in November '20 and the development of our new LCAP required meaningful consultation of community members.

We are immensely proud of our staff, students, and families, who all worked together to respond and adapt to the circumstances of the pandemic in order to continue to re-implement our hybrid program for 2020-21 and plan for a full return to school in 2021-22. We value the consistent stakeholder engagement and close collaboration achieved by our parents and staff in providing critical feedback and contributing to the ongoing planning required throughout the past year. Each member of our leadership team, led by our Director

of Community, engaged parents around their area of focus/expertise. We held virtual planning meetings, town halls, and coffee chats to provide information and solicit feedback from families. We administered multiple surveys to gather feedback on our hybrid learning program and 2021-22 plans. We used multiple platforms including newsletters, ParentsSquare, Zoom and WhatsApp mobile application to communicate with families. Language needs were a barrier to engaging with some families, so we utilized staff members to send one on one texts or make phone calls to those families to keep them connected. All of our meetings, materials, and communications were translated in Spanish.

- **Implementation of busing plan**
- **Creation of a summer program to address unfinished learning**
- **Increase in in-person connections for students, families and staff beginning in the summer of 2021, including expanded summer learning program**
- Increased parent workshops/engagement related to school-wide social-emotional learning; tiers of academic/behavioral support and; diversity, equity and inclusion
- Creation of a family engagement team, and family committees that are representative of our diverse community
- Hiring a school social worker to provide mental health/resource support to students, staff and families
- Development of K-8 appropriate behavioral supports and interventions across all areas
- Continuing to develop our family DEI scope and sequence across all grade levels, for our staff and for our families

Teacher input informed the following aspects of our current LCAP. Those related to ESSER III are highlighted:

- **Added capacity to diverse learners team starting with 2021 summer learning program, including academic intervention support for struggling learners**
- Development of a master schedule that prioritizes students and families with the least amount of access
- Investment in professional development to strengthen NSSF core pillars: co-teaching, inquiry, anti-racist teaching practices, and specialized training for diverse learners
- Development of a master schedule that responds to the planning and collaboration needs of our teachers
- Investment in additional social and emotional support for students and families (Social Worker)
- Hiring of an Interim Middle School Director to set vision and lead search for a permanent Director
- Increase in bi-lingual language capacity
- Expansion of facilities team to secure long term home

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
